Key areas

Private companies (2012-ongoing)

- Sustainability (in broad sense) (2016-2017)

- Insolvency Law applied to companies (2019-ongoing)







Private companies

A never-ending story

- New sub-form with low capital (and young members...) [2012]
- General low-capital approach (2013)
- Innovative start-ups (2012)
 - Main provision: equity crowdfunding (but also shares, voting rights, capital maintenance...)
- ... extension to innovative SMEs (2015)
- ... extension to all s.r.l. SMEs (2017)

Huuuuuuge systematic issues:

- No intervention on the civil code, for provisions affecting the 99.8% of Italian private companies
- Public vs. private companies no more?

Development of benefit business organisation (2016)

With at least unfortunate wording... Debatable whether the non-benefit are entitled to pursue a "common interest purpose" And debatable scope of interest (Public companies? Private companies?)

Reform of no-profit sector (2017- and somehow still ongoing...)

Directors' duty to provide the company with an adequate managerial, organisational and accountingsrelated structure

Since 2004 for public companies

Since 2019 for every collective entrepreneurial form
