Law students on the Erasmus programme/bilateral agreements and NordPlus students who have completed two years of law studies or more are welcome to register for exams at master's level. Please check with your exchange coordinator at your home university whether you should take courses at bachelor's or master's level.

You are required to choose at least **three full courses in one semester** (30 ECTS). The Faculty does reserve the right to cancel options if the number of students wishing to follow the course is insufficient. The semester pages will be updated from 4 June for the autumn semester 2013. We offer different courses in the spring semester 2014.
