The Conference aims at discussing different systems of judicial career, challenges, as well as international advanced practices and methods in this regards. Additionally, the conference intends to shed lights on public expectations for judges as professionals and personalities, and the balance of effectiveness of recruitment vs technocratically constructed procedures for objectiveness and transparency reasons.

Besides offering a venue for academic and policy discussion, this conference aims at contributing to public confidence and access to justice as precondition for expectations to be addresses and fulfilled meaningfully by all the stakeholders.
